Answer: The current quarter net operating cash outflows includes \$580k of cash inflows related to Industry Grants, Research Grants, and Australian Tax office boosts and Job Retention Subsidies. Whilst these inflows may not be maintained in future quarters, the Company has sufficient financing cash inflows to support future expenditures.
